The research at TBI focuses on microbial biodiversity leading to the production of novel bioactive compounds for human health and biofertilizers, biocides and gluconates for enhanced agricultural yield. The NABL accredited laboratory conducts quality control and quality assurance of agricultural produce, nutraceuticals, medicinal and aromatic plants and herbal formulations. IIIM-TBI also has a well-equipped GLP in-vivo laboratory (animal facility) to conduct preclinical studies for herbal drugs

TERMS AND CONDITIONS:

1. Applicants shall be selected and finalized for the Skill Development/ Dissertation Training programme based on the merit of their application.
2. Applicants will not be entitled to any remuneration, stipend or fellowship/ assistance in any form during the training period.

3. Training fee is Rs. 5,000/- per month to be paid by the selected applicant as per the duration of the programme. Fee shall be on non-refundable basis.
4. Training fee of the first month has to be paid in advance by the selected applicant through online transfer for confirmation of enrollment in the Skill Development/ Dissertation Training programme. The bank details are:
